What is the Device Protection Program?

The Device Protection Program (DPP) provides a low cost means to repair or replace a school owned student issued device from accidental damage, loss or theft. In some cases, participation in the program may also entitle students to ownership of the device when the program concludes. The program is voluntary. Declining the program will not prevent a student from receiving a device; however, should any damage or repairs be necessary, the assigned student would be responsible for all of the established fees up to total replacement cost.

What devices are eligible?

Students are assigned a specific device through a separate Buchanan Community Schools' Acceptable Use Policy for student devices, the device listed there will be eligible. This program applies to all students in grades 1 through 12. Please see full agreement for complete details.

What does the program cover?

The program will cover the cost of repairs or replacement from accidental damage, loss or theft. Please see the program agreement form for full details or check the link provided above.

Do I really get to keep the device?

For High School students, yes. Students in grades 9 through 12 that participate in each of the four years and/or buyout the plan in full, can keep the device upon graduation or such time as the student leaves the district (whichever occurs first). Additionally, High School students may be offered a buyout option should they not elect to enroll in the program. All other grade levels are not eligible for this portion of the program.

Program Cost

The annual cost for a given year will not increase, but may decrease. New devices are issued at grade 1, 5 and 9.

Total and single term costs are as follows:

Class of 2024: \$340.00 total or \$85.00 annually*	Grades 5 through 8: \$260 total or \$65 annually
Class of 2025: \$340.00 total or \$85.00 annually*	Grades 1 through 4: \$200 total or \$50 annually
Class of 2026: \$340.00 total or \$85.00 annually*	
Class of 2027: \$340.00 total or \$85.00 annually*
